CPNI does not include subscriber list or published information (listed or unlisted), such as your name, telephone number, and address; such information is not subject to the CPNI rules' use limitations. The Verizon Companies acknowledge that we have a duty, and you have a right, under federal and applicable state law to protect the confidentiality of your CPNI, and to direct the Verizon Companies not to use your CPNI or to limit use, disclosure of, or access to it. In some circumstances, you may also provide your Confidential Information ("CI") to the Verizon Companies.

By signing this Consent, you grant the Verizon Companies, solely for the purpose of offering you current and future products and services available from the Verizon Companies and from the Vodafone Companies\*\*, permission to use, to permit access to, and to disclose your CPNI and CI among ourselves, to the Vodafone Companies, and to our agents, contractors and partners who assist us in providing such products and services to you and who have an obligation to protect such information.

- By checking this box you also represent that you have the authority to consent, and do consent, on behalf of your current and future affiliates who receive services and products from the Verizon Companies and Vodafone Companies, to the use, disclosure, and access to CPNI and CI as above.

You have a right to disapprove of the uses of CPNI and CI as set forth above, and you may withdraw this consent at any time by notifying us in writing at [cpni-notices@verizonwireless.com](mailto:cpni-notices@verizonwireless.com) and [cpni-notices@verizonbusiness.com](mailto:cpni-notices@verizonbusiness.com). Your consent will remain valid until we receive such a notice withdrawing consent. If you refuse or withdraw consent for use or disclosure of your CPNI and CI, it will not affect our provisioning of services to which you subscribe.
